The regular meeting was called to order at 7:00 p.m.

Mr. Wayt led the meeting with the web update working with Rodney Dawson of Great Lakes Tech Solutions. The site is nearly complete with the following outstanding issues: content needs to be added to each of the individual park pages, blog entries need to be added and Mr. Dawson was working with Greg Studen on this. This section could be disabled if the board wants to go live with the site and did not have a blog entry ready according to Rodney. Mr. Wayt will contact Rodney to follow up on the work that was initiated by Greg Studen.

Mr. Wayt moved on to the new business of preparation of filing conservation easements and turned the meeting over to Peter McDonald and Brett Rodstrom of the WRLC.

The WRLC operates in 22 counties in NE Ohio and has 700 properties protected and covers over 50,000 acres of land. There are 8 conservation easements with the Russell Township Park District that covers approximately 400 acres of land. There are two properties (Dines Road and the Myers property) that are currently not under conservation easement. The Weiss easement is recommended to have an amendment to add land. Fees associated with new easements (Dines Road) would incur a cost of \$7,500 and an amendment (Myer property and Weiss easement) costing \$5,000 according to Brett Rodstrom . Those prices would be honored as long as this is the direction the new members of the park district wish to continue Brett stated.

- Mr. Abakumov inquired about the time frame needed to complete the documents and prepared for filing.
 - Mr. Rodstrom stated this would take approximately 8 weeks.

- Mr. Shanker inquired about any fees.
 - O Mr. McDonald stated that the land owner is ultimately responsible for any issues if they arrive. The WRLC enforces what the restrictions say and works with the park district to get just compensation for any damages and the funds are available should this need arrive.
- Mr. Abakumov inquired if there are any additional fees other than stated previously.
 - Mr. McDonald stated that there is no annual fee.

Mr. Abakumov started a conversation with the commissioners regarding the Dines Road easement. He stated that there were issues and the owner of the ~7.18 acres really had control over the conservation. Mr. Abakumov considered this a weak and ineffective conservation easement. The purpose of the easement is to meet the intent of Russell when the property was initially purchased. Mr. Wayt mentioned he was briefed by Greg Studen regarding the latest on the easements.

2017-89 Mr. Abakumov moved to have the WRLC prepare the proposal and the draft agreement for the easement and the amendment as discussed at the 12/11/17 meeting and was seconded by Mr. Suhay.
