WHEREAS, the amount of taxes which may be raised within the ten mill limitation will be insufficient to provide an adequate amount for the necessary requirements of the Russell Township Park District, Geauga County, Ohio;

NOW, THEREFORE, BE IT RESOLVED by the Board of Park Commissioners of the Russell Township Park District, Geauga County, Ohio, two-thirds of all members elected thereto concurring, that it is necessary to levy a tax in excess of the ten mill limitation for the benefit of the Russell Township Park District for the purpose of parks and recreation of the Russell Township Park District pursuant to Sections 5705.19(H) and 1545.21 of the Ohio Revised Code at a rate not exceeding 0.5 mill for each one dollar of valuation, which amounts to \$.05 for each \$100 of valuation, for a period of 5 years, which is an additional levy; and

The tax shall first be levied in tax year 2018 and begin collection in 2019. The subdivision has territory affected in Geauga County.

BE IT FURTHER RESOLVED that the question of levying such additional taxes be submitted to the electors of said Russell Township Park District and if passed the tax shall be levied upon the entire territory at the General Election to be held at the usual voting places within said Russell Township Park District on the 6th day of November, 2018; and

BE IT FURTHER RESOLVED that said levy be placed upon the tax list of the current year after the February settlement next succeeding the election, if a majority of the electors voting thereon vote in favor thereof; and

BE IT FURTHER RESOLVED that the Secretary of the Russell Township Park District Board of Commissioners be and is hereby directed to certify a copy of this Resolution to the Board of Elections, Geauga County, Ohio by close of business on August 8, 2018 and to notify
